With reference to the above cited subject, it is hereby informed that there is a typographical mistake happened in the point no. 1 of the outcome submitted yesterday i.e., 27-Dec-2023, wherein the total purchase consideration is erroneously mentioned as INR. 288.36 crores instead of INR. 165.24 crores. Accordingly the revised outcome shall be as follows:

- Subsequent to shareholders' approval on September 20, 2023, the completion of requisite formalities to identify a potential bidder through a fair, transparent, and competitive process, and upon the decision and recommendation of the Dis-investment Committee, the Board, subject to shareholders approval, has approved the sale of the company's 100% shareholding in its material subsidiary, Visakha Pharmacity Limited (formerly known as Ramky Pharma City (INDIA) Limited). The successful bidder is "Brij Gopal Construction Company Private Limited," and the sale consideration is Rs. 165.24 crores, determined at an arm's length share price of Rs. 180.00 per share (face value of Rs. 10.00). It is to be noted that the bidder is engaged by the Company due to the transaction in the ordinary course of business.
